

Waiver And Release Of Liability for Animal Training & Minding

Please read the terms of the Disclosure and Liability Release carefully before signing. At Sit Stay, we prioritise your pet's safety and well-being. Every effort will be made to ensure your pet's experience is safe and enjoyable and we will offer only sound, safe, and responsible instructions. Prior to using our services, please read and agree to the following Waiver and Liability Release and our Terms of Service.

Disclosure for Animal Training & Minding

1. Vaccinations/Insurance/Health of pet: I warrant that my pet is current with all vaccinations, has appropriate insurance, and is in good health to the best of my knowledge.
2. Aggressive Pets/Parasites: We reserve the right to refuse service, or to stop service in progress, if your pet poses a threat to themselves, other pets, or staff, either by aggressive behaviour, other behaviour issues, or any health problem.
3. Owner Responsibility: I agree to be solely responsible and liable for any and all acts of behaviour by my pet(s) at all times and I hereby agree to indemnify and hold The Provider and representatives harmless of any and all claims of injury, expense, costs, or damages caused to or by the actions of my pet.. This may include, but is not limited to, injury or death to my pet, injury or death to another animal(s), or injury or death to any individual providing services at our facility or other clients.
4. I understand the inherent risks in owning a pet, including but not limited to the risk of bites and scratches to myself, my pet or others.
5. The Provider cannot guarantee the outcomes of your chosen service, or its impact on your pet's current or future behaviour.
6. If it is found that your pet is not suitable for any group services booked a private lesson may be recommended (additional fee applies).
7. In the event of unfavourable weather or ground conditions your session may be postponed or cancelled, refunds will be provided if you cannot attend the next date.
8. Emergency Care: If your pet is injured or becomes ill, we reserve the right to administer first aid and procure veterinary services if necessary. If your pet receives treatment, medication, or other attention, you agree to pay all expenses directly to the veterinarian and will not hold Sit Stay Dog School or any individual providing services responsible or liable for any resulting expense.
9. Potential Risks: I acknowledge that, while great care is taken during the provision of services, there are inherent risks associated. I agree not to hold Sit Stay or any individual

performing services responsible for any injuries or adverse reactions that might result from my pet's participation in these services.

10. Photography: I agree to give The Provider the right and permission to use photos and videos of my pet taken while participating in services for illustration, art, promotion, advertising, social media, or any other purpose.
11. Release of Liability: I agree and understand and hereby release The Provider, owners, partners, contractors, volunteers, financially or otherwise, for injuries to my pet, myself, or any property of mine or others while my pet is participating in services with Sit Stay Dog School and Sit Stay Animal Training
