

# LIABILITY WAIVER

I, the undersigned, acknowledge and agree to the following terms and conditions in relation to the participation of my dog in the mobile dog training and transport services provided by Clever Canine Co. ("the Company"):

## 1. Assumption of Risk

I acknowledge that participation in any dog training, socialisation, transportation, or outdoor activity carries inherent risks. These may include, but are not limited to:

- Illness or injury to my dog, including from parasites, insects (e.g., ticks or snakes), other animals, or environmental hazards;
- Accidents, unpredictable behaviours, or altercations with other dogs;
- Unexpected health conditions or reactions during training or transport.

I voluntarily assume all such risks and release Clever Canine Co., its employees, contractors, and representatives from any liability for injury, illness, loss, or death of my dog while in their care.

## 2. Health & Behaviour

I confirm that my dog:

- Is in good physical health, free from infectious diseases, and up to date with vaccinations, flea/tick, and worming treatments;
- Does not pose a known risk to people or other dogs, and has no history of serious aggression (unless previously discussed);
- Is not under veterinary treatment for any condition that would affect their ability to safely participate.

I agree to disclose all relevant behavioural or medical information prior to participation. Clever Canine Co. reserves the right to refuse service or remove a dog from the program if behavioural or health issues compromise safety.

## 3. Veterinary Treatment & Costs

In the event of injury, illness, or medical concern during training or transport, I authorise Clever Canine Co. to seek veterinary treatment on my behalf.

I understand and agree that:

- I am solely responsible for all veterinary fees, treatment costs, medication, or emergency care required;
- Clever Canine Co. will make reasonable efforts to contact me, but may act in the best interest of my pet if I cannot be reached promptly.
- Any transport to or from a veterinary clinic by Clever Canine Co. is done in good faith and at my expense.

## 4. Transport & Training Liability

I understand that my dog will be transported in a secured, climate-controlled vehicle and cared for to industry standards. Despite best efforts, I release Clever Canine Co. from liability for any incident, injury, or loss that may occur during training, transport, or while in their care.

## 5. Personal Property

I acknowledge that Clever Canine Co. is not responsible for any loss or damage to personal items (collars, leads, harnesses, etc.) provided with my dog.

## 6. Media Use

Unless otherwise stated in writing, I give permission for Clever Canine Co. to use photos or videos of my dog for training updates and promotional purposes on social media or websites.

## 7. Agreement & Legal Release

By signing this waiver or using the Company's services, I confirm that I have read and understood the terms, and I agree to release Clever Canine Co. from any claims, liabilities, costs, or legal action arising from participation in their programs.
