



MASTER OF PUPPIES LIABILITY WAIVER & RISK ACKNOWLEDGEMENT

By proceeding with a booking, ticking the acknowledgement box, or using any Master Of Puppies service, you confirm that you have read, understood, and agree to this Liability Waiver & Risk Acknowledgement.

1. ASSUMPTION OF RISK

I acknowledge that all dog-related services involve inherent and unpredictable risks, including but not limited to:

- dog-to-dog interactions
- scratches, punctures, bites, or other injuries
- slips, trips, falls, or collisions
- escape or attempted escape
- stress-related illness
- transport incidents
- heat stress or heatstroke
- dehydration
- exhaustion
- gastric dilatation volvulus (bloat)
- aggravation of pre-existing medical or behavioural conditions
- sudden illness, injury, or death

I understand that even with reasonable supervision, these risks cannot be completely eliminated.

I voluntarily accept all inherent risks associated with my dog's participation in any Master Of Puppies service.

2. SOCIAL AND GROUP ENVIRONMENTS

I acknowledge that my dog may interact with other dogs, trainers, handlers, staff members, and members of the public.

I understand that dogs are animals and their behaviour may be unpredictable despite appropriate supervision, management, and training.

I accept the risk of normal dog play, corrections, pack dynamics, and social interaction.

3. TRAINING SERVICES

I acknowledge that behavioural training may involve physical handling, lead pressure, long lines, slip leads, head halters, crates, and electronic collars (e-collars) where appropriate.



I understand that dogs may display behavioural responses during training including lunging, barking, snapping, redirected biting, jumping, or other reactive behaviours.

I accept responsibility for participating in training and implementing the guidance provided.

I acknowledge that Master Of Puppies does not guarantee specific behavioural outcomes.

4. DAYCARE, DDD, BOARDING AND FARM SERVICES

I acknowledge that services may involve physical activity including:

- running
- pack play
- swimming
- farm exploration
- structured exercise
- free movement under supervision
- environmental exposure
- transport to and from locations

I understand that these activities increase the risk of injury or illness.

I voluntarily accept these risks.

5. TRANSPORT SERVICES

I acknowledge that use of the Doggy Bus or any transport service involves inherent risks including:

- vehicle accidents
- sudden braking
- transport-related stress
- loading and unloading incidents
- delays
- escape
- injury or death

I accept these risks.

6. VETERINARY AUTHORISATION

I authorise Master Of Puppies Pty Ltd to seek emergency veterinary treatment for my dog if required and if I cannot be contacted in a timely manner.



I agree that all veterinary, medication, treatment, and transport costs remain my responsibility.

7. RELEASE OF LIABILITY

To the maximum extent permitted by law, I release and hold harmless Master Of Puppies Pty Ltd, its directors, trainers, staff members, contractors, and representatives from any claims, liabilities, losses, costs, damages, injuries, illness, or death arising from my dog's participation in any service, except where directly caused by proven negligence.

This includes but is not limited to claims arising from:

- dog-to-dog incidents
- transport
- exercise and social activities
- training
- boarding
- veterinary treatment decisions

8. OWNER DECLARATION

By ticking the acknowledgement box and proceeding with a booking, I confirm that:

- my dog is medically fit to attend
- I have disclosed all known behavioural and medical concerns
- I understand the risks involved
- I voluntarily accept these risks
- I agree to this waiver
